

Introduction:

Please read the manual carefully before beginning installation.

The ENFORCER Multicolor Illuminated Vandal Resistant Request-To-Exit Plates use a stainless steel vandal resistant button, illuminated by a circular perimeter LED. The LED color is easily selectable during installation to not only red, green, or blue, but also yellow, cyan, magenta, or white.




Overview:

Basic Installation:

1. Run four wires through the wall to the back box.
2. Connect 2~4 wires (12VDC) to the illumination terminals.
 - a) The positive (+) terminals determine the LED color (See "LED Color Choice" below).
 - b) For 24VDC operation, install supplied resistor (1kΩ, 1/4 Watt) inline on the "+" illumination wire.
3. Connect 2 wires to either 1 and 2 (N.C.) or 3 and 4 (N.O.) terminals (see Fig. 1), using the included crimp style push on connectors.
4. Use a waterproof back box and apply silicone sealant where the faceplate meets the back box and around the mounting screws to ensure a weather-proof installation. Screw plate to the back box, using caution not to pinch any wires.



LED Color Choice:

The circular perimeter LED can be set to one or two of seven colors during installation. See "Wiring Diagram" on pg. 4 for how to set one color on standby and another during activation.


- Connect a wire from the power supply's negative (-) terminal to the switch's GND terminal (see Fig. 1).
- Connect one or more wires from the power supply's positive (+) terminal according to the color desired. See the Color Connection Chart (Fig. 2).

Fig. 2: Color Connection Chart

LED Color	Positive (+) terminal connections
Red	R (+)
Green	G (+)
Blue	B (+)
Magenta	R (+) and B (+)
Yellow	G (+) and R (+)
Cyan	B (+) and G (+)
White	R (+), B (+), and G (+)


Basic Installation with Fail-Safe Electromagnetic Lock and Keypad: Yellow Constant On LED

Basic Installation with Fail-Secure Electric Strike and Keypad: Yellow on standby, Blue on activation.



NOTES:

1. Two colors that both require multiple terminal connections cannot be used together (e.g., magenta and yellow). The result will be a constant white LED.
2. Two colors that share a terminal connection cannot be used together. The resulting LED color will be the color achieved through multiple terminal connections. (e.g., red and yellow results in a constant yellow LED)
